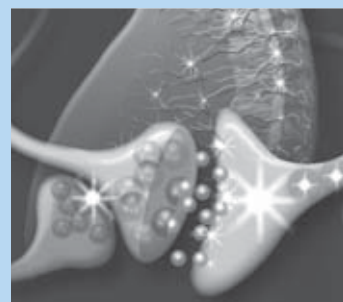
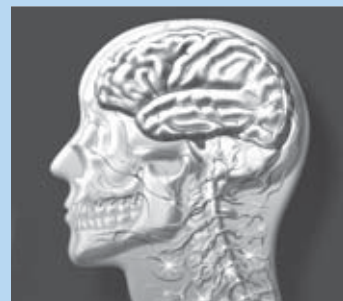

From Tower Hill tube: Follow the sign to Tower Gateway DLR. Follow the pathway for 200yds past the London Metropolitan University (on your left). At the pedestrian crossing, cross over the Minorities. Turn right at the Societe Generale building and continue over the pedestrian crossing. At the next pedestrian crossing, cross over East Smithfield and the entrance to Royal Mint Court (a large stone arch) is straight ahead of you.
